Policies & Procedures \*PLEASE READ\*

REGISTRATION FEES: A \$40 per dancer non-refundable yearly registration fee is required at time of registration. (with the exception of insufficient class enrollment) Families with 3 or more children will have a flat rate of \$90. Sessional students are not required to pay registration fees. NSF cheques will be charged a \$20 Admin Fee. \*Please note a separate cheque will be required for registration fees.

TUITION FEES: Tuition payment must be made at the time of registration. Payment can be made in full or in 9 equal post-dated cheques dated September through May. If paying by cheque, please make cheques payable for the 1st or 15th of the month. NSF cheques will be charged a \$20 Admin Fee.

WITHDRAWAL POLICY: Move Yourself Dance Ltd. requires written notice of a student's withdrawal. One month's tuition will be retained in the event of withdrawals from class(es). No withdrawals will be accepted or refunds honored after December 1, 2010. (Once costumes have been ordered, dancers are responsible to pay for costumes)

Move Yourself Dance Ltd. requires a minimum enrollment of 5 students per class, in most cases. Move Yourself Dance Ltd. reserves the right to cancel classes that have insufficient enrollment after registration. Full refunds will be issued in these circumstances.
